

DECLARATION OF CONSENT

TO THE COLLECTION AND PROCESSING OF PERSONAL DATA

I declare under the terms and for the purposes provided for in articles 7-11 and 13 of the General Data Protection Regulation (Directive EU GDPR 2016/679 of the European Parliament and of the Council of 27 April 2016), that I do hereby grant my consent under Article 6 (1) (a) of the said Directive, to the Luso-American Development Foundation, a charitable foundation established under private law, Corporate Identification Number 501 526 307, whose head office is situated at Rua do Sacramento à Lapa, nº 21, 1249-090 Lisbon, to processing my personal data, including data considered sensitive, collected through the FLAD website on the platform of call for applications for scholarship grants and other support programs (si.flad.pt) or application for funding submitted to FLAD either by post or e-mail.

FLAD guarantees confidentiality of the personal data transmitted by the data subject, as well as of all the documentation received and the information transmitted, which will be used only within the context of the purposes of the application within the limits strictly necessary to ensure their good processing and handling.

The personal data whose processing is authorized by this declaration may be subject to portability under the terms of Article 20 of GDPR, and FLAD shall undertake to use such data exclusively for the purposes for which the data were collected and shall refrain from using such data outside this context, either for its own benefit or for the benefit of third parties. FLAD shall only transmit personal data collected from third parties in such cases as are required for the fulfilment of the purposes of this Declaration, namely, for purposes of processing and management of applications for funding, as well as legal obligations to which FLAD is subject, notably, insurers, banking services, computer services, accounting services, judicial authorities, regulatory authorities and other public entities, public notaries, auditors, authorized representatives/lawyers.

FLAD shall keep, at all times, on the respective website, the contact details of the data controller and of the data protection officer.

I further declare, under the terms and for the purposes of the provisions of Articles 13 and 22 of GDPR, that I have taken due note of the following rights to which I am entitled in relation to the processing of my personal data:

- a. To withdraw my consent with regard to the processing of my personal data whose legal basis is consent;
- b. To object to the continued processing of my personal data;

- c. To request from the controller of my personal data access to such data as well as their rectification or erasure, including the exercise of the "right to be forgotten";
- d. To lodge a complaint with the CNPD, whose contact details may be obtained from the Luso-American Development Foundation for that purpose;
- e. To be informed, upon request, of the purposes of the processing, the categories of data involved, the identity of the recipients of such data, as well as the period for which my data may be stored;
- f. To be informed on which data are undergoing processing and, on any information, available as to the origin of such data, by electronic means, should it not be via this document;
- g. Exercise the rights of consultation, access, rectification, updating or deletion of my personal data made available within the context and for the purposes laid down above, by means of communication, for that purpose, by email sent to Luso-American Development Foundation (fladport@flad.pt) or, by the same means, to the data protection officer (dados@flad.pt).
